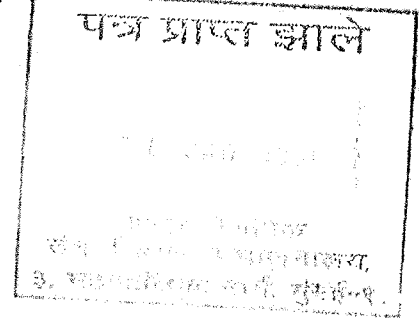

Madam/Sir,

It is a matter of great concern that over 1.50 lakh people lose their lives every year in India due to road accidents and many more suffer debilitating injuries. This causes immense economic hardship and emotional trauma to the affected families. There is an urgent need to make our roads safer because the loss of lives and limbs cannot be accepted as an inevitable consequence of mobility. The Central and the State Governments have been implementing various measures to make our roads safer. But the magnitude and gravity of the problem is such that these steps alone will not suffice. There is a need for society at large to take cognizance of the issue and make road safety awareness a mass movement.


2. To sensitise all the stakeholders on safer road mobility, the Central and State Governments observe "Road Safety Week" every year, wherein various activities are taken up for advocacy and promotion.

3. The 31st Road Safety Week will be observed from 11th to 17th January, 2020. It is proposed to initiate a pre-campaign on Road Safety on 11th and 12th January as a build up to the main events. The details of Road Safety Activities scheduled to be organised during the Week are attached herewith for ready reference (Annexure-I).

4. The 'Parliamentary Constituency Committee for Road Safety' has been reconstituted with the District Collectors being designated as Member Secretary. It is requested that the District Collectors may be asked to get in touch with the Parliament members in order to solicit their convenience for scheduling a meeting of the said Committee during the week. An Action Taken Report in the matter may also be sent to this Ministry thereafter.

5. To assist the states in creating a mass movement for road safety awareness, the Ministry also intends to provide financial support @ Rs.10.00 lakh per state/ UT and @ Rs. 2.00 lakh per district for road safety activities during the Road Safety week. All the State/UTs are therefore requested to submit their proposal in the format given at Annexure-II to the Ministry latest by 27th December, 2019.

I, Deepanshu Gupta, am writing this letter on behalf of the **Ministry of Road Transport and Highways**.

Road accidents are recognized as the leading cause of deaths among youth between the ages of 5-29 in India and worldwide. In 2017, more than 48,746 two-wheeler users died in road mishaps. Incidentally, 73.8 percent of them did not wear a helmet. As many as 97,588 people died in 2018 due to accidents caused by over speeding. The magnitude and gravity of the issue are such that it requires a multi-stakeholder approach.

As youth is the most vulnerable section in terms of road accidents, the involvement of youth in its eradication becomes mandatory. It's high time when youths should come forward to take action to improve road safety scenario by contributing their bit.

31st National Road Safety Week will be observed across India from **11 January to 17 January** and this year's theme is "**Bringing Change Through Youth Power**". Ministry of Road Transport and Highways, Government of India encourage all the colleges to be a part of this week-long campaign to put youth in the center of our strategy building for a safer India.
